



## RUPES MARKETING MATERIALS - TERMS & CONDITIONS OF USE

Please read these terms and conditions carefully before accessing, downloading and using any contents on this website. By accessing to our website, you agree to be bound by these terms and conditions.

You may download, print, use and display on your website, social networking profile page ('Your Site') or at your store the RUPES content on this website that is available for download, including but not limited to photos of the products, brochures, leaflets, posters, banners, videos and other advertising materials (the "Downloadable Content") subject to these Terms and Conditions.

All title, ownership rights and intellectual property rights in and to the Downloadable Content on this website (the 'Content') shall remain the property of RUPES S.p.A. ("Us" or "We") at all times. You may not change any notices regarding the copyrights, trademarks or other rights that accompany any Content, nor add any statement to Your Site or to any material you produce that features the Content, including but not limited to any of you store or print material, which implies in any way that you own any such rights in the content.

### 1. LICENCE

Subject to the terms of these Terms and Conditions, We grants you the right to download, print and use the Content, and a non-exclusive, non-transferable, revocable license in respect of the Content in order for you to display the Rupes Content on Your Site and to use the Content at your store. You may not copy, re-publish, edit, manipulate, alter, add to, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the Content, any updates, or any part thereof. We have no obligation to provide any maintenance or support services in respect of the Content.

### 2. USE OF THE CONTENT

2.1 You may not use the Content on any websites or in any material that:

2.5 You may not directly or indirectly suggest any endorsement or approval by RUPES of (i) Your Site or (ii) any non-Rupes entity, product or content or (iii) any views expressed within Your Site or on any material you produce that features the Content without RUPES' prior written approval.

2.6 You may not use the Content in any way that could bring RUPES into disrepute or otherwise cause any loss or damage to Us. In particular, you may not use the Content in a comparative way against manufacturers of products competing with the RUPES brands, nor may you criticize RUPES in the context of the Content.

2.7 You acknowledge that RUPES has sole editorial control over the Content at all times and We reserve the right at any time to interrupt, restrict (without cause and without notice to you), change, suspend or terminate any or all Content or your access to the Content at our sole discretion and without liability whatsoever, including, but not limited to, for fraudulent or inappropriate use of the Content. You agree to immediately notify Us of any unauthorized use, or suspected unauthorized use, of your account or any other breach of security. We shall not be liable for any loss or damage arising from your failure to comply with the above requirements.



3.2 We shall not be responsible for any costs associated with you accessing the Content, downloading and/or printing it and including it on Your Site or in print or advertising material.

#### 4. WARRANTIES & LIABILITY

4.1 You warrant to RUPES that: (i) Your Site and any material that you produce that features the Content fully complies with, and shall continue to comply fully with all applicable laws and regulations, including but not limited to, where necessary, any advertising laws; (ii) Your Site is not an Excluded Website; (iii) any materials that you produce featuring the Content is of sufficiently high quality as would be expected if We produced such materials.

4.2 You warrant and undertake to notify Us immediately once you become aware of any problems associated with the Content, including but not limited to fraudulent or inappropriate use or access. In the event that you become aware of any inappropriate use or access to the Content by a third party, you will not take any actions or communicate with the third party without first notifying Us and you will provide us all reasonable assistance in taking any steps that are necessary against the third party.

4.3 To the maximum extent permitted by law, the Content is made available by Us on an "as is" and "as available" basis and We gives no warranty of any kind in relation to the Content. RUPES hereby disclaims all warranties and conditions with respect to the Content, whether express, implied or statutory, including but not limited to warranties related to non-infringement of third party rights.

4.4 RUPES has taken all reasonable care to ensure that the Content on this website contains no errors, viruses or defects; however, RUPES does not warrant that this is the case or that your use of the Content will be uninterrupted or error-free. You expressly acknowledge and agree that the use of the Content is at your own discretion and risk. You are advised to take all reasonable precautions to protect Your Site from virus infection.

#### 6. LIMITATION OF LIABILITY

To the extent permitted by law, in no event shall RUPES be liable for any unforeseeable losses whatsoever, including, without limitation, damages for loss of profits, business interruption or any other business losses, arising out of or related to your use or inability to use the Content, however caused and whether in contract, tort or otherwise.



## 7. TERMINATION

The license is effective until terminated by Us. We may permanently terminate or temporarily suspend your access to all or any part of the Content without notice and liability for any reason, including but not limited to, if in our sole determination you breach any provision of these Terms and Conditions. Upon termination of this license, you shall immediately (i) cease all use of the Content wherever it is used, (ii) withdraw all Content from Your Site, (iii) remove and/ or take down all material and advertising material at your store that features the Content, (iv) prevent any continued access to the Content and (v) destroy all copies, full or partial, of the Content.

## 8. GENERAL

8.1 You may not assign or sub-license the license to use the Content, which is granted to you in accordance with these Terms and Conditions, wholly or partly, to any third party. These Terms and Conditions shall be interpreted in accordance with the laws of Italy and subject to the exclusive jurisdiction of the Italian Courts. Our failure to enforce any provision of these Terms and Conditions shall not be deemed a waiver of such provision nor of our right to enforce such provision. Clauses 4, 5, 6, 7 and 8 shall survive termination of these Terms and Conditions. Should any part or provision of these Terms and Conditions be held unlawful, void, invalid or unenforceable, that part or provision shall be deemed severable from these Terms and Conditions and shall not affect the validity and enforceability of any remaining provisions. These Terms and Conditions constitute the only terms between Us and you governing your use of the Content.

8.2 We do not intend to make changes to these Terms and Conditions often but reserve the right to do so. Each time you download the Content you will be asked to accept the Terms and Conditions in force at that time. In the event that we do make changes to the Terms and Conditions you agree to be bound by the revised Terms and Conditions. If you do not agree to the revised terms, you will not be permitted to download or print any Content and you should no longer use or display any Content previously downloaded and printed.
